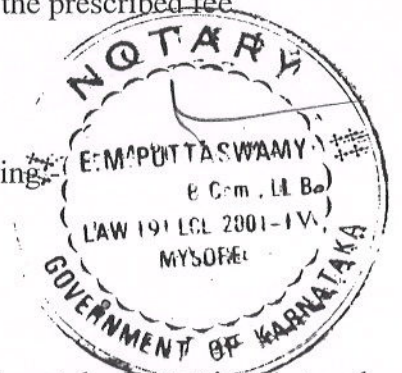

## Terms & Conditions

1. The school has been registered under in accordance with provisions of the Child Rights Education Act – 2009 and the Karnataka Education Act, 1983 and its regulations and the accreditation has been renewed up to the registered school class. [Primary / Secondary Education] 1 to 5<sup>th</sup> [1 to 5, 1 to 8, 6 to 8, 9 and 10] Extra Classes and divisions are not permitted except in this school.
2. The school shall operate under rules enacted under the Karnataka Education Act 1983 and the Child Rights Education Act 2009.
3. Allocation of 25 percent seats to vulnerable classes under the rules enacted by the Child Rights and Refugees Act 2009; The Government shall be authorized to register fixed seats under RTE for schools covered under RTE Act 2009. [The government has set rules to facilitate enrollement in adjacent schools where children's parents live, so that children are enrolled in government, government-funded educational institutions. Otherwise, private schools will enroll government-registered children and continue their education up to the elementary level, allowing these children to continue to practice without discrimination.
4. Regulatory government releases child fees as enumerated in the RTE rule as outlined in Clause 1 of this Act restricted. As per the RTE Act the school shall not collect any fees in this regard.
5. The school and the school board are forbidden to spin any capital capitulation fee and voluntary donations at any time during enrollment or later.
6. Statement of State Government Notification N: D-31 2GC 2014, dated 27.07.2019 published on the Department's website and school notice board, no fee is charged beyond the prescribed fee.
7. Enrollment of students within the stipulated time framed by the school.
8. The School / Governing body cannot refuse enrolment against the following:
  - (i) Due to lack of age proof
  - (ii) Caste, religion, place of birth, language,
  - (iii) If the area is sought after an extended period of time.
9. Take all safety measures in accordance with the RTE Act and Rules, Karnataka Education Act and Rules. (In relevance to Fire Safety Certificate, Building safety certificate and safety of Child Learning as per KSCPCR and NCPCR)
10. The School / Governing body as follows:
  - (i) No child is entitled to be failed at elementary education at School.
  - (ii) No child shall be physically or mentally abused.
  - (iii) No child shall be required to pass any board examination until he has completed his primary education
  - (iv) Every child who completes primary education shall be certified under the RTE Rule – 21 and Karnataka Education Act and Rules.

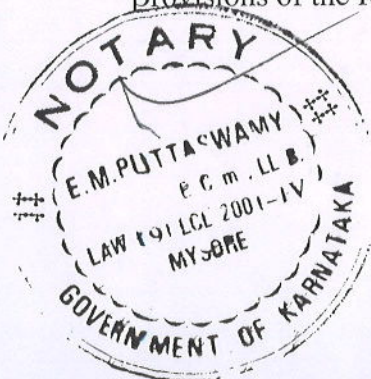

- (viii) Teachers perform the duties prescribed under Rule 17 of the RTE Act and Rules and the Karnataka Education Act and Rules and do not engage in private tuition for supervisory considerations under the teachers Act Sec-24(1)
