SI. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 48 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 7 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

SI. No.	CONDITIONS FOR COMPLIANCE
1	1. The total number of sections of the school shall be restricted to 48, of which not more than 1/3 sections may be used for senior secondary classes and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws subject to the availability of rooms of more than 500 ft dimension.
2	2. The school has constructed ramps at various places. It shall install a hand rail along all ramps for safety of CWSN and submit compliance within 3 months on SARAS.
3	3. The school has shown 1 CWSN toilet on the ground floor. That too is not as per norms. one of the existing cubicles has been converted into CWSN toilet but it is too narrow for a wheelchair or walker to navigate as is clear from the video as well. The school shall create separate CWSN toilets for boys and girls on every floor, as per norms prescribed in RPwD Act and guidelines issued by the Board and submit compliance on SARAS within 3 months.
4	4. The school has shown 1 lift,IC has reported that there is only 1 lift in 1 of the blocks where as there are 4 blocks in the school. The school shall construct ramps/install lifts in the remaining three blocks as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS.
5	5. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time.
6	6.The school shall follow the SoPs of the Board for its labs, library and sports facilities.
7	7.The school shall conduct training of its teachers with CoE Bengaluru within 3 months and submit compliance on SARAS.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.

- 5. The school to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
